## **Annex 2 Conditions consistent with the Operating Schedule**

1. The premises will have digital CCTV system that covers many areas of the shop floor, including the proposed area which will be used for beer and wine. Images will be retained for a minimum of 21 days and made available on enforcement request.
2. A member of the Management team will be on the premises all of the time the store is open. A persona will have responsibility for the premises whilst the premises are open.
3. A till prompt will appear on the initial sale of alcohol that will remind the seller of their responsibilities including not to sell alcohol to anyone under the age of 18.

7. All staff members engaged, or to be engaged, in selling alcohol on the premises shall receive full training pertinent to the Licensing Act, specifically in regard age-restricted sales, and the refusal of sales to persons believed to be under the influence of alcohol
8. Induction training must be completed, and fully documented, prior to the sale of alcohol by the staff member and regular refresher training.
9. All restricted sales training undertaken by staff members shall be fully documented and recorded. All training records shall be made available to the Sussex Police and the local Trading Standards service upon request.
10. At all times the premises is open and undertaking licensable activity, members of staff must be able
